Rules and Regulations

Please keep for future reference

- 1.) Dogs must be at least ten weeks old.
- 2.) All dogs older than six months old must be neutered/spayed.
- 3.) All dogs must be on some sort of flea prevention product (Advantage, Frontline, Advantix, Etc.)
- 4.) All dogs must be up to date on their vaccinations. These include Distemper, Hepatitis, Leptospirosis,, Parainfluenza, Parvovirus, and Bordatella (Kennel Cough). These are usually included in the "DHLPP" "5-in -1" or "6-in-1" it may or may not include Bordatella. Everybody must provide written proof that your dog has received **ALL** of these.
- 5.) For the safety of everyone, all dogs must not be dog, food, or toy aggressive.
- 6.) There is a \$10 application fee to be paid when the application is turned in. Nobody will be permitted into the play pad without a properly filled out Application and Health and Temperament form.
- 7.) All dogs must be in good health and provide a negative result on a fecal sample (within the past 30 days). All dogs that have been infected with a communicable disease in the last thirty days, must provide a certification of good health from their veterinarian to be admitted or re-admitted to the Play Pad.
- 8.) Hours of operation for the Play Pad are Tuesday through Friday from 7:30 to 6:00 and Saturday 7:30 to 5:00. If you are late, your dog will spend the night, and there will be a \$15 boarding fee assessed.
